

BoxOffice by DStv Rent To Win Star Wars: The Rise of Skywalker Merchandise Competition

In order to enter and be eligible to win the current BoxOffice competition(s), you agree to be bound by all of the Terms and Conditions outlined below, as well as the additional Terms and Conditions that govern the use of BoxOffice, and any of DStv's products and services, available to read on their respective websites.

STANDARD TERMS AND CONDITIONS FOR COMPETITIONS

2. 9. It is your responsibility to ensure that any information which you provide to us is accurate, complete and up to date.

10. Any costs or expenses which you may incur other than in respect of those items specifically included in a prize are for your own account. MultiChoice will not be responsible for any costs or expenses which you, or your partner (if applicable), incur during and for purposes of your entry into the competition and your acceptance and/or use of a prize.

 - 25.3. you indemnify and hold us and our affiliates harmless against any claim by any person, (whether direct, indirect, incidental, punitive or consequential) of any nature, whether arising from negligence or any other cause, relating to any death, injury, loss and/or damage which may be suffered howsoever arising in relation to your failure (or that of your partner, if applicable) to comply therewith.

For purposes hereof, "affiliate" means our partners, co promoters and sponsors of this competition, our subsidiaries, our and their subsidiaries and respective holding companies, the subsidiaries of their holding companies, and our and their directors, officers, employees, agents and representatives.
27. These terms and conditions will be construed, interpreted and enforced in accordance with the laws of contract and dispute resolution in the Republic of South Africa.

28. MultiChoice and the judges' decision on any matter concerning the competition and/or arising out of these terms and conditions is final and binding on you, and no correspondence will be entered into.

**ADDITIONAL TERMS AND CONDITIONS PERTAINING TO THE BoxOffice by DStv

BoxOffice by DStv, in partnership with The Walt Disney Company is running a competition on its transactional-video-on-demand service that is available on the Explora PVR, HD PVR, SD PVR and BoxOffice website www.boxoffice.dstv.com, promoting the rentals of the movie Star Wars: The Rise of Skywalker from 20 April 2020 to 07 June 2020.
3. The competition is running on BoxOffice in South Africa only and is thus open to customers residing in SA only.
4. Qualifying rentals must be completed on the Explora PVR, HD PVR, SD PVR and / or the BoxOffice website on www.boxoffice.dstv.com.
